DEFINITIONS AND INTERPRETATION

- a) **"Go2Africa website"** means the website owned and operated by Go2Africa and located at <http://www.go2africa.com>, including any page, part or element thereof and furthermore all domain names linked to such website;
- b) **"African Wildlife Guide website"** means the website owned and operated by Go2Africa and located at <http://www.africanwildlifeguide.com> including any page, part or element thereof and furthermore all domain names linked to such website;
- c) **"Go2Africa"** means Go2Africa (Pty) Ltd, a private company registered in terms of the laws of South Africa reg. no. 1998/015392/07;
- d) **"User"** means any person who enters or uses the Go2Africa and African Wildlife Guide websites, notwithstanding the fact that such a person only visits the home page of the Go2Africa or African Wildlife Guide websites;
- e) References to the singular shall include the plural and vice versa;
- f) Notwithstanding the fact that hyperlinks in these terms and conditions should be considered part of these terms and conditions in terms of section 11(3) of the ECT Act, the fact that some or all of the hyperlinks may be non-operational, shall not play a role in determination of the validity of the remainder of the terms and conditions.
- g) By using this website the User accepts these terms and conditions.

1. **ALLOWED USE AND LICENSE**

- 1.1. Go2Africa licenses the User to view, download and print the content of the Go2Africa website, provided that such content is used for private, personal, educational and/or non-commercial purposes only;
- 1.2. Users may not use the Go2Africa website for any harmful or illegal purposes or for the creation, storage or sending of unsolicited commercial communications.

- 2.1. - 5.4. Go2Africa website; and/or
- 5.5. change the software and hardware required to access and use the Go2Africa website.

provided that such change will not affect any service transaction already entered into with Go2Africa.

6. PRIVACY

- 6.1. Go2Africa shall take all reasonable steps to protect the personal information of Users and for the purpose of this clause, "personal information" shall be defined as detailed in the Promotion of Access to Information Act 2 of 2000 (PAIA);
- 6.2. Go2Africa may electronically collect, store and use the following personal information of Users:



- 6.2.1. name and surname;
 - 6.2.2. contact numbers;
 - 6.2.3. non-personal browsing habits and click patterns;
 - 6.2.4. e-mail address;
 - 6.2.5. IP address; and/or
 - 6.2.6. User selected username and password.
- 6.3. Go2Africa collects, stores and uses the abovementioned information for the following purposes:
- 6.3.1. To communicate requested information to the User; and
 - 6.3.2. To provide the User with access to restricted pages on this website; and
 - 6.3.3. To compile non-personal statistical information about browsing habits, click-patterns and access to the Go2Africa website; and
 - 6.3.4. To notify the User of services, offers and promotions from time to time.
- 6.4. Information detailed above is collected either electronically by using cookies or is provided voluntarily by the User. Users may determine cookie use independently through their browser settings;
- 6.5. Go2Africa may collect, maintain and store any information collected from users, however, this information will never be shared or sold; it could, however, be disclosed to a third party if mandated to do so by a legal order from a South African court; and
- 6.6. Go2Africa owns and retains all rights to non-personal statistical information collected and compiled by the Go2Africa website.

7. HYPERLINKS TO THIRD PARTY SITES

- 7.1. Go2Africa may provide hyperlinks to websites not controlled by Go2Africa (target sites) and such links do not imply any endorsement, agreement with or support for the content of such target sites; and

8. SECURITY

- 8.1. Go2Africa shall take all reasonable steps to secure the content of the Go2Africa website and the information provided by and collected from Users from unauthorized access and/or disclosure.
- 8.2. Go2Africa is under no legal duty to encrypt any content or communications from and to the Go2Africa website and is also under no legal duty to provide digital authentication of any page on the Go2Africa website;

- 9.1. Subject to the provisions of sections 43(5) and 43(6) of the ECT Act, if applicable, and as far as allowed by law, Go2Africa (including its owners, employees, suppliers, Internet service providers, partners, affiliates and agents) shall not be liable for any damage, loss or liability of any nature incurred by whomever and resulting from:
- 9.1.1. access to the Go2Africa website;

 - 9.1.5. content available on the Go2Africa website;

Subject to the provisions of the Regulation of Interception of Communications (RIC) Act 70 of 2002, the User agrees to Go2Africa's right to intercept, block, filter, read, delete, disclose and use all communications sent or posted by the User to the Go2Africa website, its staff and employees; and
- 11.2. The User agrees and acknowledges that the consent provided by the User in clause 12.1 satisfies the "writing" requirement as detailed in the ECT Act and the RIC Act.

12. ENTIRE AGREEMENT AND SEVERABILITY

- 12.1. These terms and conditions constitute the entire agreement between Go2Africa and the User and shall take precedent over any disclaimers and/or legal notices attached to any communications and/or postings received by Go2Africa from the User;
- 12.2. Any failure by Go2Africa to exercise or enforce any right or provision shall in no way constitute a waiver of such right or provision; and
- 12.3. In the event that any term or condition detailed herein is found unenforceable or invalid for any reason, such term(s) or condition(s) shall be severable from the remaining terms and conditions. The remaining terms and conditions shall remain enforceable and applicable.

13. AGREEMENT IN TERMS OF SECTION 21 OF THE ECT ACT

The User and Go2Africa agree that:

- 13.1. the User shall be bound to these terms and conditions and such agreement is concluded in Cape Town (South Africa) at the time the User enters the Go2Africa website for the first time;
- 13.2. data messages (as defined in the ECT Act) addressed by the User to Go2Africa shall only be deemed to have been received if and when responded to;

- 13.6. the User agrees and warrants that data messages that are sent to Go2Africa from a computer, IP address or mobile device normally used by or owned by the User, was sent and/or authorised by the User personally.

14. APPLICABLE AND GOVERNING LAW

Subject to the arbitration referred to above, the Go2Africa website is hosted, controlled, and operated from the Republic of South Africa and therefore the South African law enforced by the South African courts governs the use or inability to use the Go2Africa website, its content, services and these terms and conditions.

15. LEGAL COSTS
