

Go2Africa Referral Program T&Cs

1. How the Program Works

All travelers who have booked at least one trip with Go2Africa can refer friends or family who have not enquired before with Go2Africa.

2. What Counts as a Referral?

An Invited Person must be someone who:

- (a) Has not travelled with Go2Africa before, and
- (b) Is not currently planning a trip with Go2Africa.

3. Rewards and Offers

Referrer:

- \$500 travel credit towards their next unforgettable Safari OR
- \$500 travel credits towards an experience on their up-and-coming Go2Africa safari OR
- \$500 donated to the Endangered Wildlife Trust, on their behalf.

Referral will receive \$500 discount towards their first trip with Go2Africa.

This will apply for each booking referred, regardless of the number of travelers.

There is no limit to how many referral credits you can earn or how many you can apply towards a future trip. There is however a limit to 1 \$500 donation per referrer.

4. To Qualify for the Credit:

- (a) Must be referred to by someone who has booked with Go2Africa
- (b) The Invited Person must not be traveling with the Referrer.

5. Issuing of Rewards and Offers

Invited Person's credit must be used within 12 months of their first enquiry with Go2Africa. Referrers' credit must be used by paying a deposit for a trip within 24 months of the Invited Person's trip completion.

6. Privacy

All personal information collected and processed as part of the referral program will be used in accordance with Go2Africa's Privacy Policy, available at https://www.go2africa.com/privacy-policy. Under the applicable laws and regulations, Go2Africa shall be responsible for collecting and processing such personal information.

7. General

7.1. These Referral Terms are published by Go2Africa (Pty) Ltd ("we", "us", "our" and "Go2Africa"). Our referral program - as displayed on our Website

https://www.go2africa.com/referral-program/ - and these Terms form a binding agreement for both Referrers and Invited Persons.

- 7.2. This referral program permits you to invite your contacts to participate in one or more referral program(s).
- 7.3. You may only invite personal friends, family members, acquaintances and colleagues to this referral program.

8. Completed Referrals and Limit

- 8.1. A Completed Referral is when a Referrer refers this Program to one of its contacts. Subsequently, that contact will either sign-up, make a purchase or complete whatever action is determined as a referral above which is not canceled or disputed.
- 8.2. All Invited Persons must be new and first-time Users. Existing Users cannot participate in and benefit from the referral program.
- 8.3. You represent all personal information is 100% correct and up to date. We may monitor your use of the referral program or request your ID to verify your identity before issuing rewards.

9. Restrictions

- 9.1. This Program cannot be combined with other Go2Africa referral programs, discounts, vouchers, benefits or incentives. By participating in this referral program, we may restrict you from any other promotion, program, discount, or vouchers.
- 9.2. You understand and agree that you must not use referral methods that are bothersome to the recipients. Moreover, your participation in the referral program must not violate the applicable law, including but not limited to anti-Spam legislation, which is mass distribution of unsolicited messages.
- 9.3. You must not publish our referral program on any sites or platforms that house any Adult Content, Alcohol, Tobacco, Gambling, Games and Online Casinos, Political Content, and any form of illegal activities.
- 9.4. You must not at any time, invite or refer people who are unknown to you.
- 9.5. You must only use our referral program for personal use and refrain from its use for commercial purposes.
- 9.6. Credit is not transferable, and no cash alternative is available.
- 9.7. Travel agents and Go2Africa employees or their families are not eligible for this referral program.

10. Term and Termination

- 10.1. This referral program will run until the announced date and that date can be extended or restricted. We may also in our sole discretion notify Users that the referral program has ended with immediate effect.
- 10.2. Any referral made before the end of the referral program can still participate. However, we may exclude referrals at our sole discretion made after its termination date.
- 10.3. We may terminate this referral program at any time, including your participation or the availability of its benefits.

11. Exclusive Relationship

- 11.1. You understand and agree that you are only the User of our services and/or products, and refrain from implying any other affiliation or legal relationship with us.
- 11.2. You understand and agree that you are never authorised to legally bind our company.
- 11.3. You must never create any materials that contain our branding, trademark, (part of) our corporate identity.
- 11.4. By participating in the referral program you must not represent yourself in duplicate, agent or intermediary of our company

12. Privacy and Information

- 12.1. You undertake to respect the privacy rights of the people you invite to our referral program and direct to our website.
- 12.2. When referring other people, you must always inform them about the applicable terms and conditions and privacy policy. You must do so before they participate in the referral program, and leave their personal information.

13. Amendments

We may amend the terms and conditions of our referral program. We may offer and/or restrict additional incentives, benefits and programs. As a result, additional terms may apply. You agree that you are aware of those amended and additional terms.

14. Violations and Termination

- 14.1. In case we suspect any violations of these terms or otherwise tampering with, fraud or unreasonable use of our referral program, we may in our sole discretion cancel the distribution of any discount, benefit or payout.
- 14.2. If you are a current or former employee, contractor or affiliate of our company, we may restrict your participation in the referral program, and we may restrict or cancel your participation with immediate effect.
- 14.3. You must comply with all applicable laws and regulations, and refrain from violating any third party rights. These rights include any copyright, trademark or other proprietary rights.

15. Disclaimer and Indemnification

- 15.1. We offer our referral program and its benefits only on an "as is" and "as available" basis. We may remove, change and update the referral program in our sole discretion. We will never make any promises or guarantees about the content and information of our referral program. We disclaim our responsibility for any information that is incorrect or has errors.
- 15.2. Our referral program is based on our best efforts. You acknowledge and agree that we can never guarantee any benefit or result from participating in the referral program.
- 15.3. You will defend, indemnify and hold Go2Africa (Pty) Ltd harmless from and against all claims, damages, liabilities, losses, expenses and costs (including reasonable attorneys fees) arising out of your participation in the referral program.

16. No Correspondence, Disputes and Refunds

With regards to the distribution of discounts, vouchers, incentives, prizes, awards or other benefits, no correspondence will be entered into. Moreover, we shall never respond to any complaint or accept any dispute about the referral program, and the abovementioned benefits. are provided "as is" and we never refund or exchange such benefits.
